# **Tribunal Order to Produce Documents**

## 1. Order to Produce Documents

#### **BC Human Rights Code**

Section 32 of the BC *Human Rights Code* provides that sections 34(3), (4) and 49 of the *Administrative Tribunals Act* apply to the BC Human Rights Tribunal.

#### Administrative Tribunal Act

Sections 34(3), (4) and 49 of the Administrative Tribunal Act state:

### Power to compel witnesses and order disclosure

34(3) Subject to section 29, at any time before or during a hearing, but before its decision, the tribunal may make an order requiring a person

(a) to attend an oral or electronic hearing to give evidence on oath or affirmation or in any other manner that

is admissible and relevant to an issue in an application, or

(b) to produce for the tribunal or a party a document or other thing in the person's possession or control, as specified by the tribunal, that is admissible and relevant to an issue in an application.

34(4) The tribunal may apply to the court for an order

(a) directing a person to comply with an order made by the tribunal under subsection (3), or

(b) directing any directors and officers of a person to cause the person to comply with an order made by the tribunal under subsection (3).

### Contempt proceeding for uncooperative witness or other person

49(1) The failure or refusal of a person summoned as a witness to do any of the following makes the person, on application to the court by the tribunal, liable to be committed for contempt as if in breach of an order or judgment of the court:

(a) attend a hearing;

(b) take an oath or affirmation;

(c) answer questions;

(d) produce the records or things in their custody or possession.

49(2) The failure or refusal of a person to comply with an order or direction under section 48 makes the person, on application to the court by the tribunal, liable to be committed for contempt as if in breach of an order or judgment of the court.

49(3) Subsections (1) and (2) do not limit the conduct for which a finding of contempt may be made by the court in respect of conduct by a person in a proceeding before the tribunal.

### 2. Setting Aside an Order to Produce Documents

A person who has been served with an Order to Produce Documents may ask the Tribunal in writing to set aside the order. You must make this request within **14 days of the date of the order** and must include the reasons for the request.

Rule 34(3) of the Tribunal's *Rules of Practice and Procedure* require the person seeking the order to serve it on you promptly.
